Discussion:

1. Development Presentation: Provision Holdings, LLC., Ryan Oros

Mr. Oros presented the proposed GreyStar mixed-use development project located at Highway 74 and Oakley Industrial Boulevard. The site is 15 acres and envisions 300-320 proposed apartment units with 3 stories. Envisions 2-3 spaces for start-up business - Café or boutique retail space. Proposes a functional park/greenspace, clubhouse, and other amenities for the development. Will need a modification to the zoning on the site. May seek Development Authority incentives at some time in the future. A brief question and answer period followed the presentation. Mr. Oros agreed to take the feedback provided by the Authority and come back in the future to present an updated project.

There was no executive session conducted.

Director Jiggetts was given a point of personal privilege to announce that he is hosting a Virtual Homebased Business Expo on May 1, 2021. Directors and the public are invited. The flyer to the Expo will be shared with all Directors.
