American Rescue Fund Act (ARPA) Presentation

The Authority Attorney presented a presentation regarding the American Rescue Fund Act and potential funding available to the Development Authority by the City. The City received \$11,352,517 in ARPA funds. The City Manager has committed to providing some funding to the Development Authority. The Authority Attorney will continue to work with the City Manager to facilitate the funding committed by the City Manager. At some point in the future, the Board will have to indicate a specific use for the proposed funding.

Planning/Retreat Discussion

Economic Development Director Artie Jones provided an overview of a proposed strategic planning retreat for the Board. The date has been identified as Thursday, November 10, 2022. The location will be provided at a later time once confirmed. There will not be a cost for the retreat and the retreat will be sponsored by the Economic Development Department.

A motion was made by Director Jordan and second by Director Pollard to confirm the Board retreat for November 10, 2022, as offered by Mr. Jones. The motion was approved 8-1. Director Coleman voted in opposition.
